In exchange for the consideration of my job application by Tin Hut BBQ(hereinafter called "the Company"), I agree that: Neither the acceptance of this application nor the subsequent entry into any type of employment relationship, either in the position applied for or any other position, and regardless of the contents of employee handbooks, personnel manuals, benefit plans, policy statements, and the like as they may exist from time to time, or other Company practices, shall serve to create an actual or implied contract of employment, or to confer any right to remain an employee of Tin Hut BBQ, or otherwise to change in any respect the employment-at-will relationship between it and the undersigned, and that relationship cannot be altered except by a written instrument signed by the President /General Manager of the Company. Since Tin Hut BBQ is subject to terms under federal contracts you will be subject to a background investigation to obtain the appropriate credentials to enter federal installation. If at anytime the background investigation finds derogatory information you may be subject to immediate termination.
